**Subject: AB 1510 (Dababneh): Athletic Trainers
Request for Support**

Dear Assembly Member Chu:

The Association of Independent California Colleges and Universities (AICCU) respectfully requests that the Assembly Arts, Entertainment, Sports, Tourism and Internet Media Committee supports Assembly Bill 1510 (Dababneh). AB 1510 would create the Athletic Training Practice Act to license and regulate athletic trainers through a committee under the California Occupational Therapy Board.

AICCU represents 79 WASC-accredited, private, nonprofit colleges and universities. AICCU institutions educate 188,000 undergraduate students, and 144,000 graduate students, producing 22% of all undergraduates and 55% of graduate professionals into the workforce each year. Currently, there are eight AICCU member institutions that offer an athletic trainers program.

In addition to enrolling students in these programs, colleges and universities also employ athletic trainers. Athletic trainers have the responsibilities of preventing, evaluating, and rehabilitating a variety of injuries that can happen on and off the sports field. Currently, there is no certification and training requirement in California, making it the only state that does not regulate the profession of athletic training. AB 1510 would bring California into accordance with other states, by licensing and regulating the profession. This bill will ensure that athletic trainers receive the proper education and experience to provide care to student athletes specifically, and Californians in general.

For these reasons, AICCU respectfully urges the committee to support AB 1510.
